No.NBE-1/Ex-9/2017-18 :: In supercession of this Office Notification No. 52/2017 dated Kohima, the 5th October 2017, it is hereby notified that the Class VIII & Class IX Final Examinations 2017 is postponed and rescheduled due to reported theft of the confidential packets of Class VIII & Class IX at Govt. High School, Sovima, Dimapur.

The Class IX Final Examination 2017 shall now be held from 30th November 2017 to 8th December 2017. The revised routine is being published separately. The Examination of other classes should not be affected by this change of schedule.

The Board shall issue the new question papers for **English**, **Mathematics**, **Social Sciences**, **Alternative English** and **Environmental Education** subjects. For the remaining subjects, schools shall use the question papers already issued by the Board. The new question papers shall be delivered in the district headquarters on the **29**th **November 2017** by the Board Officials. Schools under Kohima district shall collect it from the Board's office.

The Set I question papers **shall not** be opened till the examination is over.

The Heads of Institution shall collect the confidential packets on the specified dates from the respective district designated schools.

As an immediate penal action, the examination centre for Govt. High School, Sovima, Dimapur is cancelled. The centre of Class IX Final Examination 2017 for this school shall be Govt. High School, Diphupar 'B'. Further course of action will be initiated as per rules.

Note: The next examination for Class VIII shall be held on the 6th December 2017.
